

## ACRYLITE<sup>®</sup> LED sign grade 45 and 65 clear Extruded Sheet

Roehm America LLC warrants all users that, for a period of 30 years from the date of original purchase, clear, smooth ACRYLITE® LED sign grade 45 and 65 acrylic sheet manufactured by Roehm America will not undergo a change in light transmission of more than 2-15%, when tested in accordance with the procedure specified in ASTM-D-1003\*.

Roehm America LLC warrants all users that, for a period of 30 years from the date of original purchase, clear, smooth ACRYLITE® LED sign grade 45 and 65 acrylic sheet manufactured by Roehm America will not undergo a yellowness index increase greater than 4-10, when tested in accordance with the procedures specified in ASTM-D-1925.\*

Not covered under this warranty are yellowing or loss of light transmission caused by dirt, scratches, breakage, or damage to the ACRYLITE<sup>®</sup> sheet. Also not covered under this warranty are yellowing caused by exposure to incompatible chemicals, sealants or gaskets, storage or use for significant periods at 20°F above ambient, or UV light above the naturally occurring levels or other high energy radiation sources.

THE FOREGOING IS THE SOLE WARRANTY APPLICABLE TO ACRYLITE® SHEET, EXPRESS OR IMPLIED. ALL OTHER WARRANTIES ARE EXCLUDED.

The sole liability of Roehm America in respect of ACRYLITE<sup>®</sup> sheet shall be the replacement of any sheet found by Roehm America not to meet this warranty or, at the option of Roehm America, the refund of the purchase price therefore. Roehm America shall have no liability under any circumstances for the cost of removal of defective sheet or the installation of replacement sheet, or for damage to property, or for indirect, incidental, or consequential damages.

If you write, be sure to include your address and a phone number where you may be reached. An Roehm America representative will contact you to examine the sheet. At such examination, you will be required to present to the representative a sales slip or other evidence satisfactory to Roehm America that you purchased the ACRYLITE® sheet within 30 years from the date of your letter or telephone call.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you.
