ACRYLITE® Soundstop Limited 30 year Warranty

Colorless Noise Barrier Sheet

Roehm America, LLC warrants all users that, for a period of 30 years from the date of original purchase, colorless ACRYLITE® Soundstop manufactured by Roehm America will not undergo a change in light transmission of more than 2–15% when tested in accordance with the procedure specified in ASTM D1003*.

Roehm America, LLC warrants all users that, for a period of 30 years from the date of original purchase, colorless ACRYLITE® Soundstop manufactured by Roehm America will not undergo a yellowness index increase greater than 4–7, when tested in accordance with the procedures specified in ASTM–D1925.*

Not covered under this warranty are yellowing or loss of light transmission caused by dirt, scratches, breakage, or damage to the ACRYLITE® Soundstop panel. Also not covered under this warranty are yellowing caused by exposure to incompatible chemicals, sealants or gaskets, storage or use for significant periods at 20°F above ambient, or UV light above the naturally occurring levels or other high energy radiation sources.

THE FOREGOING IS THE SOLE WARRANTY APPLICABLE TO ACRYLITE® SOUNDSTOP, EXPRESS OR IMPLIED. ALL OTHER WARRANTIES ARE EXCLUDED.

The sole liability of Roehm America in respect of ACRYLITE® Soundstop shall be the replacement of any panel found by Roehm America not to meet this warranty or, at the option of Roehm America, the refund of the purchase price therefore. Roehm America shall have no liability under any circumstances for the cost of removal of defective panel or the installation of replacement panel, or for damage to property, or for indirect, incidental, or consequential damages.

Be sure to include your address and a phone number where you may be reached. An Evonik Cyro representative will contact you to examine the panel. At such examination, you will be required to present to the representative a sales slip or other evidence satisfactory to Roehm America that you purchased the ACRYLITE® Soundstop panel within 30 years from the date of your letter or email.
