**POLYVANTIS Sanford LLC warrants all users that, for a period of 10 years from the date of original purchase, clear, smooth ACRYLITE® OA070 acrylic tube manufactured by POLYVANTIS Sanford LLC will not undergo a decrease in light transmission of more than 8%, when tested in accordance with the procedure specified in ASTM-D-1003\*.**

POLYVANTIS Sanford LLC warrants all users that, for a period of 10 years from the date of original purchase, colorless, smooth, ACRYLITE® clear – OA070 acrylic tube manufactured by POLYVANTIS Sanford LLC will not undergo a yellowness index increase greater than 5, when tested in accordance with the procedures specified in ASTM-E-313\*

This warranty does not cover tube exposed to artificial light sources emitting intense amounts of UVB or higher energy radiation.

Not covered under this warranty are yellowing or loss of light transmission caused by dirt, scratches, breakage, or damage to the ACRYLITE® tube. Also not covered under this warranty are yellowing caused by exposure to incompatible chemicals, sealants or gaskets, storage or use for significant periods at 20°F above ambient, or UV light above the naturally occurring levels or other high energy radiation sources.

THE FOREGOING IS THE SOLE WARRANTY APPLICABLE TO ACRYLITE® TUBE, EXPRESS OR IMPLIED. ALL OTHER WARRANTIES ARE EXCLUDED.

The sole liability of POLYVANTIS Sanford LLC in respect of ACRYLITE® tube shall be the replacement of any tube found by POLYVANTIS Sanford LLC not to meet this warranty or, at the option of POLYVANTIS Sanford LLC, the refund of the purchase price therefore. POLYVANTIS Sanford LLC shall have no liability under any circumstances for the cost of removal of defective tube or the installation of replacement tube, or for damage to property, or for indirect, incidental, or consequential damages.

If you write, be sure to include your address and a phone number where you may be reached. A POLYVANTIS Sanford LLC representative will contact you to examine the tube. At such examination, you will be required to present to the representative a sales slip or other evidence satisfactory to POLYVANTIS Sanford LLC that you purchased the ACRYLITE® tube within 10 years from the date of your letter or telephone call.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
