REACH: Roehm America LLC evaluates its products for substances listed under Regulation (EC) 1907/2006 of the EU concerning Registration, Evaluation, Authorisation and Restriction of CHemicals (REACH). The REACH Annex XIV candidate Substances of Very High Concern (SVHC) list was updated on 23Jan2024 to contain 240 substances, see: https://echa.europa.eu/candidate-list-table. Roehm also evaluates Annex XVII of REACH. This Restricted list was updated on 12Dec2023 and contains 73 entries, see: https://echa.europa.eu/substances-restricted-under-reach.

RoHS: Roehm America LLC also evaluates EU Directive 2015/863 of 31Mar2015 amending Annex II to Directive 2011/65/EU of the European Union as regards the list of restricted substances in Electrical and Electronic Equipment (EEE).
