

TSCA Section 8(a)(7) PFAS Regulatory Statement ACRYLITE® Extruded Sheet Products

Date: 09 April 2026

Section 8(a)(7) of the US Toxic Substances Control Act (TSCA) requires reporting and recordkeeping for per- and polyfluoroalkyl substances (PFAS), see 40 CFR 705. The Section 8(a)(7) rule defines “PFAS” as a chemical substance structurally containing at least one of the following three sub-structures:

- (1) R-(CF₂)-CF(R)R”, where both the CF₂ and CF moieties are saturated carbons.
- (2) R-CF₂OCF₂-R’, where R and R’ can either be F, O, or saturated carbons.
- (3) CF₃C(CF₃)R’R”, where R’ and R” can either be F or saturated carbons.

The EPA provides a file to help identify reportable PFAS. The file includes a “PFAS without Confidential Business Information ID Claims” list with unique CAS #s, and a “PFAS with Confidential Business Information ID Claims” list with structurally descriptive generic names. POLYVANTIS Sanford LLC does not check raw materials against structural definitions or structurally descriptive generic names; checks are only made against unique CAS#s.
